

Privacy- and cookie policy

The processing of personal data is done in accordance with the requirements of the General Data Protection Regulation. This privacy and cookie policy describes how Export Partner BV handles personal data.

When do we process your personal data?

We collect and process your personal data:

- - When you apply for one of our job openings.

Why do we collect your personal data?

We collect and process your personal data for the performance of our services. More specifically, your personal data is processed to:

- make offers to you and/or provide information about our (new) products and/or services and other activities and to tailor these to your requirements;

- To support communication and to carry out (direct) marketing purposes;
- For internal analyses and process improvement, the development of products and/or services and market research;
- To be able to process an application for a vacancy;
- To handle complaints and requests for information;
- To comply with legal obligations.

Retention period

We do not keep your personal data longer than is necessary to achieve the goals stated in this privacy policy. Anonymized, the data may be kept longer by Export Partner BV. And in so far as this is permitted on the grounds of legislation and regulations.

We use cookies on our website. Cookies are small, simple text files that your computer receives when you visit our website. Cookies are used on almost all websites. The use of cookies is important for our service and we would like to inform you as well as possible about the use of these cookies.

With the help of cookies Export Partner BV makes sure that we remember your settings and preferences. This makes a subsequent visit to our website easier and faster. Cookies also enable us to see how the website is being used and where we can improve it further.

We use the following cookies:

- **Functional cookies**
- These cookies are indispensable for the functioning of our website. They ensure, for example, an automatic login or the automatic completion of your data. Also, products you have viewed and placed in your shopping cart are remembered when you visit our website again at a later time.
- **Optimization cookies**
- We use these cookies mainly to collect information. With this information we see how often the website is visited, which pages are visited most and which pages are effective. This allows us to optimize your ease of use. For this we use Google Analytics, see below. This data always remains anonymous and we cannot use it to identify you, as a person.

Google Analytics

Export Partner BV makes use of Google Analytics cookies in order to analyse the use of the website and services. Export Partner BV has concluded a processing agreement with Google Analytics. Hereby we have chosen to only register a part of your IP-address and data are not shared with other services of Google Inc. Google Analytics cookies give Export Partner BV information about the use and navigation within/between the website and/or services. This information helps Export Partner BV to improve the layout of the website and services in order to better tailor them to the needs of its users, analyse trends and track navigation behaviour.
